Ben Hufffman – 301 Highland Ave. – stated apts. have deteriorated greatly in the last 10 yrs.

Tony Paterno -307 Highland Ave - apts. have been an eyesore in the area for many yrs. - thanked the city for their support.

Warren Shirkey -514 Highland Ave. - stated he served on the city's property board many yrs ago and nuisance was present then.

Jim McClanahan – 404 Highland Ave. – has three young children – profanity written on bldg. – is a tremendous eyesore.

Sue Grimes – 423 Highland Ave. – is afraid for her safety in the neighborhood. Thanks for city's support.

Councilman Paul spoke and thanked all who came to show support in voting to abate a long time nuisance.

Councilman Griffith spoke stating arranging long-term financing in the acquisition of the bldg. would help the city.

Therefore, Mayor Mullens appointed a committee to meet and bring back to council several options for acquisition: Ben Paul, Chair, Jeff Means, Finance Chair, Dayton Griffith, Carlton Lee, City Manager, and Steve DeBarr, City Engineer. Mayor Mullens stated citizens should also be asked to attend these meetings.

Councilman Stevens stated all speakers were simply addressing tenants only. Felt when the landowners license expired, city should deny renewal.

Councilman Neal – felt problem is due in part to property owners – run down buildings with undesirable tenants fall back on property owners and city not following up with restricted codes.

Therefore, by a 7-2 roll call vote the motion was approved to adopt the ordinance with Mr. Neal and Mr. Stevens voting in the negative.
